Boarding Policy and Information

- 1. Animals will be admitted for boarding from 8:00am- 7:30pm on weekdays and from 8:00am- 1:30pm on Saturdays. The same hours apply for discharge from boarding.
- 2. There will be no admissions or pick-ups after hours, Sundays, or holidays.
- 3. This hospital does not provide 24 hour supervision.
- **4.** If animals have fleas or ticks upon admission, they will be treated and bathed at the owners expense.
- **5.** <u>All dogs</u> must have a current DHPP (Distemper/Parvo), Canine Influenza, and Bordetella (Kennel Cough) vaccinations, given by a licensed veterinarian, or receive vaccinations upon admission.
- The Bordetella (Kennel Cough) vaccination is required every 6 months for all patients boarding.
- A Fecal check is required within the 6 months prior to the patients boarding, or will be done
 upon admission. In the case of a positive result, the patient will be treated at the owners
 expense.
- **6.** <u>All cats</u> must have a current FCPC (Distemper) vaccination, given by a licensed veterinarian, or receive vaccination upon admission.
- 7. <u>All dogs and cats</u> are required by Maryland State Law to have a current Rabies vaccination, given by a licensed veterinarian, or receive vaccination upon admission.
- **8.** It is the owners responsibility to provide us with written confirmation of vaccinations if they were given at another hospital. All vaccinations are given at the owners expense.
- **9.** Bones, blankets, towels, toys, etc. may be left at the owners risk. We cannot guarantee the return of such items.
- **10.** We reserve the right to refuse admission of any animal that the doctor feels might have a contagious disease.
- 11. In the event of an illness of a boarded animal, we will make every attempt to contact the owner. If we are unable to do so, we will treat the animal at the owners expense. It is important that you provide us with an emergency number below.
- 12. We will be as careful as possible to prevent the spread of any contagious disease. However, when animals are kept in a building with other animals, such spread occasionally occurs and we cannot guarantee against it or be responsible for it. No animals with contagious diseases are ever knowingly admitted for hospitalization or boarding at this facility. Animals are housed individually unless otherwise requested and cages are thoroughly sanitized before and after each use.
- **13.** When time and space allow, we will bathe animals boarding here at the owners request and expense. Any animal that soils themselves while here will be bathed free of charge. Any animal that is admitted in a soiled condition will be bathed at the owners expense.
